3. DERBY CLASSES WILL PAY 30% OF PURSE TO HIGH GO ROUND SCORES, 70% TO FINAL PLACEMENTS.
4. ALL CLASSES WILL PAY BACK ACCORDING TO THE NRCHA SCALE.
5. MUST BE A MEMBER OF THE NRCHA FOR ALL APPROVED CLASSES. YOU MAY JOIN AT THE SHOW.
6. NRCHA RULES APPLY AND AN \$8 NRCHA FEE WILL BE CHARGED FOR ALL APPROVED CLASSES.
7. HORSES MUST BE SHOWN IN ORDER DRAWN.
8. PROTESTS MAY BE FILED IN ACCORDANCE WITH NRCHA RULES.
