Derby Requirements

Entries close 4pm, Wednesday.

The Derby is open to four and five year old horses only. Horses may be shown in Snaffle Bit or Hackamore.

You must enter the Open to enter the Int. Open. No similar requirement for other classes.

\$1k Ltd Derby drawn with Open or Non Pro.

For the \$1,000 Limited Derby, the rider may not have exceeded \$1,000 in lifetime earnings in all NRCHA events. For the \$5,000 Novice Horse Open Derby & \$3,500 Novice Horse Non Pro Derby, the horse may not have won more than \$5,000 & \$3,500 respectively in lifetime earnings in all NRCHA events at the time of the show.

Payouts

In Derby and Bridle Spectacular classes 30% will be paid to high scores in the herd, reined, and fence work (10% each) and 70% will be paid to overall high scores.

80% of entry fees paid back in Added Money classes -100% in jackpot classes.

All paybacks according to the NRCHA scale.

General

NRCHA rules apply to all classes. \$8 fee charged for NRCHA classes. \$5 fee for AQHA classes.

Closing times for each class will be posted at the show. Must show in order drawn.

For concurrent classes, pay only the highest Cattle/Office fee. Open & Non Pro classes run separately, with Open before Non Pro.

NRCHA membership required for all approved classes. CRCA membership required for classes except Youth & Unapproved Ltd.

RV hookups, payable to State Fair.
